

JIMMY AWARDS. NATIONAL FINALIST INFORMATION GUIDE

Omaha Performing Arts is proud to present the 12th annual **Nebraska Theater Academy Showcase at the Orpheum Theater on Saturday, May 31st, 2025 at 7:30pm.** This red-carpet, Tony Awards® inspired event is a tribute to the enthusiasm, dedication, and accomplishments of our state's high school and middle school theater programs. Participants have the opportunity to win awards and perform as a part of that evening's program, which will be hosted by Broadway performer and Omaha native, Kevyn Morrow. Students, faculty and staff from participating schools are encouraged to attend and celebrate theater in our schools!

Congratulations on being selected as a Jimmy Awards® National Finalist! In addition to receiving a medal onstage at the Orpheum Theater, you will perform a solo in one of two medleys alongside other top students from across the state as well as performing in the Lead Ensemble number (regardless of if you won an award or not). From the group of National Finalists, two top students will be named National Nominees (1 Best Actor and 1 Best Actress) and go on to compete at the Broadway League's Jimmy Awards® in NYC. Nominees will be announced live onstage at the showcase.

The top two National Nominees will receive an all-expenses-paid trip to NYC where they will join award-winning students from across the country to experience a week of coaching with Broadway performers, casting directors, and industry professionals culminating in a special performance at the Minskoff Theatre on Broadway. Nominees will also have the chance to compete for scholarships, see Broadway shows, audition for casting directors, and more as a part of the weeklong intensive. • For students driving themselves and parking at Creighton for the week, directions/maps on how to get to and from Creighton University are provided on pages 12-13.

Student performers should use the following entrances at the performance/rehearsal venues:

- When you arrive on the first day for check-in you will use the Holland Center Stage Door located on the north side of the building between 12th and 13th Streets on Dodge Street.
- When you check-out after the performance you will use the Orpheum Theater main lobby.

AVAILABILITY & DEADLINES

- We recognize that some students may be eligible to perform in more than one group. National Finalists will perform in one of two medleys as well as in the Lead Ensemble number, regardless if they have won an award for Outstanding Lead Role.
- Showcase rehearsals are scheduled to run **Tuesday, May 27 Saturday, May 31, 2025.** Students must be available for all scheduled activities. A full rehearsal schedule is available on pages 9-10 (all scheduled activities are subject to change). Please note that observers are not allowed at rehearsals
- All online forms for the Nebraska Theater Academy Showcase are due by Thursday, May 15, 2025 (https://o-pa.org/learn-engage/national-finalist-form). Forms and materials for the Jimmy Awards are due Friday, May 23, 2025 and should be sent to NTA@O-pa.org.
- To be eligible for the Jimmy Awards® National Nominees must be available for the entire Jimmy Awards® intensive week from Friday, June 12 Tuesday, June 24, 2025.

CREATIVE TEAM

National Finalists will work with Broadway choreographers and professional music directors, musicians, and stage managers as they prepare to perform in one of two solo medleys and the Lead Ensemble number at the Orpheum Theater. National Finalists will be accompanied by a live pit band.

MUSIC

Students will be sent music for the National Finalist medley and the Lead Ensemble number at least 1 week prior to rehearsals. Music will be sent as PDF attachments to the student and parent emails provided on the online Student Information Form. Students are expected to rehearse their vocal parts and be memorized prior to the first rehearsal; however, students should print their music and bring it with them to rehearsals for notetaking purposes. A limited number of printed copies will be available for students in need.

AWARDS

National Finalists will receive medals onstage as a part of the showcase. From the group of National Finalists 2 top students will be named National Nominees and receive trophies for Best Actor and Best Actress. National Nominees will be announced live onstage.

CHECK-IN

Students should arrive for check-in at the Holland Center Stage Door, located on the north side of the building between 12th and 13th Streets on Dodge Street at 8:30am on Tuesday, May 27, 2025. If a student will be late, parents/guardians must notify O-pa staff or we will contact their parent and emergency contact(s). Students will be asked to provide any missing paperwork at this time.

Students will check into their dorm after that evening's rehearsal and should bring any items they've packed to the Holland Center that morning (O-pa staff will assist students with storage of these items during that day's rehearsal). All persons entering the building will go through security screening. See full rehearsal schedule for details on pages 9-10. Students driving themselves should review the parking section of this document for information on where to park upon arrival.

CHECK-OUT

Students will check-out of the dorm before the dress rehearsal the morning of Saturday, May 31, 2025 and should bring any items they've packed to the Orpheum Theater (O-pa staff will assist students with storage of these items during the rehearsal/performance; however, items must be collected by students after the performance). After the performance has ended, check-out will take place in the main lobby of the Orpheum Theater.

Parents/guardians of students who are minors will be asked on the online form to list up to 3 approved persons that their student can be released to at check out, along with an emergency contact. Parents have the option of requiring valid ID as part of the checkout process (e.g. Driver's License or other official photo ID). Parents/guardians can choose whether or not an approved person's presence is required to complete the check-in/out process.

HEALTH & SAFETY

Omaha Performing Arts reserves the right to dismiss students at any time for any reason. If a student is sick/does not feel well, they should NOT attend. If a student exhibits illness symptoms (including but not limited to headache, chills, temperature, etc.) the student will be immediately sent home. If the student is a minor, O-pa staff will notify their parent/guardian and emergency contact for immediate dismissal.

O-pa staff does not provide participants or visitors with medication, including over the counter remedies such as ibuprofen, Tylenol, Aspirin, Tums, etc. to any participant for any reason. Participants must bring and administer their own medication if needed.

HOUSING REQUIREMENT

All National Finalists are required to stay in Creighton University dormitory housing throughout the rehearsal period Tuesday, May 27 – Saturday, May 31, 2025 (housing, meals and transportation to/from rehearsals as well as adult supervision by trained O-pa chaperones will be provided at no cost to students).

PARKING & TRANSPORTATION

Upon arrival, students driving themselves should park their cars under the overhang in the 12th Street Arrival Plaza. At the end of the first day of rehearsal, an O-pa staff member will lead students to the Creighton University parking lot where they will park for the rest of the week. Students who plan to drive themselves to/from rehearsals must have parent permission indicated on their Student Information Form that was completed online. Maps/directions to and from Creighton University can be found on pages 12-13 of this guide.

O-pa has arranged for transportation to and from the Creighton dorms for students staying on campus. Nebraska Theater Academy Chaperones will accompany students to/from the dorms and rehearsal venues each day.

MEALS

All meals will be provided for free. Students will meet chaperones in the lobby of their dorm each morning to walk to Creighton's Brandies Dining Hall for breakfast. Lunch and dinner will be provided at rehearsal venues each day. If a student has food allergies/dietary restrictions that we should be aware of please include this information on the Student Medical Information Form online. Although meals are provided, it is strongly encouraged that students bring snacks and their own water bottle. Water stations will be available at the rehearsal venues throughout the day.

TICKETS

Tickets will go on sale for the general public on Friday, May 9, 2025 starting at just \$14! Showcase Ensemble Students DO NOT need tickets and will be provided with special seating; however, all performers will receive a promo code to reserve 1 complimentary ticket to share with a guest. Promo codes will be provided to schools by **Thursday, May 1, 2025.**

CODE OF CONDUCT

At O-pa, we are committed to providing a safe, creative, and learning-friendly environment to explore the arts. **We depend on** *everyone* **to help us meet this goal!** Students are expected to behave appropriately and always follow instructions from O-pa personnel.

Expressly prohibited behavior includes, but is not limited to:

- Violating local, state, or federal laws.
- Violence, harassment, bullying and discrimination of any kind will not be tolerated.
- Causing willful damage to venue facilities or equipment.
- Failing to comply with the venue security procedures.
- Bringing outside alcohol, controlled substances (other than personally prescribed medicines), firearms or knives into the venue (see page 6 for full list of prohibited items).
- Bringing animals (other than legal service animals) into the venue.
- Using or distributing tobacco or vaping products in the venue.
- Using offensive language as defined by O-pa personnel.

CURFEW

For your safety, an 11pm curfew will be enforced. This curfew is a Nebraska Theater Academy policy. Students must be in their assigned rooms by 11pm following rehearsal. Nebraska Theater Academy Chaperones will provide nightly bed checks to ensure this policy is enforced. No outside guests are permitted at the Creighton dorms, including immediate family without prior notice and approval by O-pa staff. Students are not allowed to leave the Creighton dorms or rehearsal venues. Nebraska Theater Academy Chaperones will accompany students to breakfast each morning and to/from rehearsals at the Holland Center or Orpheum Theater.

SECURITY

Students will not be allowed to leave rehearsal venues unaccompanied between rehearsals for any reason. If a student goes missing during rehearsals O-pa staff will contact security and follow "Code Adam" protocol – no one will be allowed to enter/exit the building until the student is located. Students are expected to be punctual. O-pa staff will contact the teacher and parent/legal guardian of students who fail to check-in or check-out or arrive late during any point of the rehearsal period.

To provide a safe learning environment, O-pa is equipped with security staff and video surveillance of the Holland Center and Orpheum Theater. Students and parents are encouraged to report any suspicious or inappropriate behavior. Holland Center security is located on the ground floor of the Holland Center near the stage door. Orpheum security is located near the stage door on 15th and Harney.

INCIDENT REPORTS

For the safety of all participants, O-pa staff will provide a locked box in the lobby (or other easily accessible location) where participants can anonymously submit safety concerns which will be assessed by O-pa staff each day.

ONLINE SAFETY POLICY

All students are expected to practice online safety. Notify a staff member or parent/guardian immediately if you come across information, messages, interactions with any other person involved with, teaching, or attending the education event, or images that are inappropriate, threatening, dangerous, or make you feel uncomfortable. Do not engage with O-pa staff or guest artists through any social media platform, other than the platform designated for the education program or activity. Any communication with O-pa staff and guest artists outside of scheduled education program/class time should take place through O-pa emails and phone numbers. Sending sexually explicit photos or messages is strictly prohibited while using the O-pa platforms designated for education activities. Sharing and/or receiving personal information, including, without limitation, phone number, social security number, address, email address, date of birth, social media account address, such as Facebook, Twitter, Instagram, Snapchat, etc. (collectively the "personal information") by any student or the student's parent/guardian in connection with any virtual O-pa education activity conducted via Zoom, social media or any other virtual platform is strictly prohibited. O-pa is not responsible if personal information is shared and/or received by any student or the student's parent/guardian via Zoom, social media or any other virtual platform during education activities. O-pa is not responsible for any consequence arising from such sharing and/or receiving of personal information. For participants under the age of 19, parents/guardians must strictly monitor internet use in connection with all virtual O-pa education events.

PHONE & INTERNET

There is in-room telephone and internet connection in the Creighton dorms. The Holland Center and Orpheum Theater have free Wi-Fi (a password and username will be given to students when they arrive at rehearsal).

DORM KEYS & ACCESS CARDS

Students will be given individual keys to their dormitory rooms and a building access card upon check-in at Creighton University. If a student's key or access card gets lost or stolen, the student is responsible to pay \$45 for their key and \$1 for their access card.

SUBSTANCE ABUSE

Using any illegal drug is punishable by law and will not be condoned. In addition, the Nebraska Theater Academy program will not permit smoking and alcohol, even if a student has reached the Nebraska State legal age to do so. Any student discovered using any of these substances will be immediately expelled and disqualified from participating in the showcase.

RESPECT

Be respectful at all times – bullying, profanity, and discriminatory language is strictly prohibited. Discrimination or harassment based on race, creed, color, national origin, nationality, ancestry, age, sex (including pregnancy), familial status, marital/civil union status, religion, domestic partnership status, affectional or sexual orientation, gender identity and expression, atypical hereditary cellular or blood trait, genetic information, liability for military service, protected hairstyle, and mental or physical disability (including perceived disability, and AIDS and HIV status) is strictly prohibited. We will not condone discriminatory conduct toward any person. Students are also expected to treat all property and equipment, both on the Creighton University campus and at O-pa venues, with respect. Students will be held liable for any damaged equipment, furniture or space. Students are expected to keep sound to reasonable levels and to comply with requests to reduce sound levels that are intrusive.

PERSONAL BELONGINGS

Students are responsible for all personal belongings. O-pa will not be held responsible for any lost, damaged or stolen property.

PROHIBITED ITEMS

To ensure the highest level of safety and security at O-pa, the following items are prohibited:

- Large bags or back packs larger than 14" x 14" x 6"
- Laser pointers
- Hard coolers or similar containers
- Sealed packages of any kind
- Noise making devices of any kind (i.e. bells, whistles, horns, etc.)
- Alcohol
- Illegal drugs or substances
- devices, pocket/utility knives or cutting instruments
- Selfie-sticks or other telescopic devices

- Flags, banners or signs
- Animals (unless a service animal)
- Any materials constituting unauthorized advertising or promotion
- Drones (UAS-Unmanned Aircraft Systems) or other model aircraft
- Hover boards
- No weapons of any kind, including lawfully concealed firearms, pyrotechnics, flares or incendiary
- Any other items deemed inappropriate or dangerous by O-pa security or staff

ATTIRE

Rehearsal

During rehearsals, students should wear comfortable clothing and shoes that they are able to move in for long periods of time. Students are not to wear clothing, jewelry or other apparel which may be offensive to others, including T-shirts with offensive graphics and/or language and sexually explicit clothing that is revealing.

Showcase

The showcase is a red-carpet event – students are encouraged (but not required) to dress up for this celebratory occasion! National Finalists will wear their red-carpet attire for their medley performance. Because National Finalists are also performing as part of the Lead Ensemble number, they should plan to wear their Nebraska Theater Academy T-Shirt (provided at rehearsal) + black pants/leggings or a black skirt with opaque black tights + black shoes for those performances. Dressing rooms will be provided for students to change before/after their performances.

EMERGENCIES

Upon registration, emergency contact information and participant-specific medical information must be provided to O-pa staff in case of emergency.

ALLERGIES

O-pa will make best efforts to accommodate food allergies and preferences whenever meals are served as a part of class/camp; however **O-pa is not a nut-free campus**. In the event of a severe allergic reaction, O-pa staff members are not trained in the administration of emergency treatment and will immediately call 911 and notify security who will provide immediate and basic emergency medical care until a first responder/certified medical personnel member arrives on the scene. O-pa requires participants with known severe allergies to always keep an Epi-pen or other appropriate remedy on-hand.

BUILDING EVACUATIONS

In the event of a fire or similar occurrence requiring an evacuation, a white light will flash with an announcement stating, "There is an emergency in the building, please evacuate." Remain calm. O-pa staff will direct participants to evacuate the building using building evacuation routes to designated assembly points outside the building and then O-pa staff will take attendance. All individuals should wait until security gives the approval to return to the building. O-pa staff will contact caregivers not onsite at the earliest opportunity with a status report.

INJURY & ILLNESS

If a participant experiences an injury or illness that is life threatening, O-pa staff will immediately call 911 and notify security who will provide immediate and basic emergency medical care until a first-responder/certified medical personnel arrive on the scene. If the participant is a minor, O-pa staff will notify their parent/guardian and emergency contact. If a minor experiences an accident or injury that is not life-threatening O-pa staff will provide access to a first aid kit and notify their parent.

PERSONAL

If there is a personal/family emergency and you need to reach a participant during class/camp activities, please contact O-pa security at 402.661.8555.

TORNADO OR TAKE SHELTER

In the event of a tornado or similar occurrence, a white light will flash with an announcement stating, "The National Weather Service has issued a tornado warning for the greater Omaha-area. Please leave your seats and proceed to the shelter." O-pa staff will direct participants to the appropriate storm shelter. O-pa security will make an "all clear" announcement when it is safe to resume normal activity. O-pa staff will contact caregivers not onsite at the earliest opportunity with a status report.

- Shower shoes/caddy
- Robe
- Bath towel, hand towel and/or washcloth
- Plastic cup

Prescription/medications:

- Pain reliver
- Allergy medication

Bedding:

- Blanket
- Pillow

Vanities:

- Make-up and remover
- Hair dryer
- Curling iron/straightener/styling tools
- Curlers
- Brush/comb
- Lotion
- Sunscreen
- Nail clippers/file
- Hair clips/bobby pins/etc.

Miscellaneous:

- Photo ID (required for dorm check-in)
- Cell phone/charger
- Laptop or tablet/charger
- Book
- Snacks
- Umbrella and/or rain coat





SUMMARY OF REQUIRED MATERIALS

Below is a summary of all the required materials each Regional Award Program (RAP) must submit on behalf of each of their two (2) Nominees.

Forms

- 1. Nominee Information Form: Please see the Nominee Information Form for required responses. All four (4) pages must be completed and returned to your Regional Awards Program.
- 2. Nominee Participation Forms: Please see the Nominee Participation Forms for required responses. All eight (8) pages must be completed and returned to your Regional Awards Program. The Nominee and their Parent/Guardian must sign in multiple places.
- 3. Nominee Wardrobe Information Form: Each Nominee is required to bring three (3) formal outfits to NYC. Nominees may choose to bring the costume they wore in their performance of their Nominated Role, though it is not required. The Jimmy Awards may provide some or all of a Nominee's costume pieces for the ceremony. Each Nominee must submit measurements and videos of their required costumes. Please see the Nominee Wardrobe Descriptions for more detailed information and the Nominee Wardrobe Information Form for required responses.
- **4. Nominee Music Submission Form:** The Nominee will list a total of six (6) songs that fall under two (2) categories: two (2) Song Selections from Nominated Qualifying Role & four (4) Solo Song Selections. The Nominee must be off-book and prepared to sing all six (6) submissions upon arrival in NYC. A flowchart detailing how music selections are utilized throughout Jimmys Week.

Song Selections from Nominated Qualifying Role – The two (2) most prominent songs from the Nominee's performance of their Qualifying Role in their high school musical to potentially be performed during the ceremony if the nominee is placed in the Character Group following the Preliminary Adjudication. If you do not know the key in which the song(s) was performed, sheet music will be provided to the Nominee in the original key. Please note:

- a. If the role only has one (1) solo selection in the show, only list one (1) song.
- b. Do not list a song from the musical that is not performed by the Nominee's Qualifying Role.
- c. There is no guarantee either of these songs will be chosen to be performed if the Nominee is in The Character Group. Final song selection is at the discretion of the Music Director/Arranger.

Solo Song Selections – The Nominee's two (2) up-tempo and two (2) ballad musical theatre solo selections to prepare for individual work with the Solo Coaches during Jimmy Awards Week should the Nominee be assigned to The Character Group following the Preliminary Adjudication. One (1) of these four (4) songs will be chosen in collaboration with the Nominee's Solo Coach to be performed for the Minskoff Judges on Sunday, June 22nd. If selected as one of the eight (8) finalists, the Nominee will perform said song on the stage of the Minskoff Theatre in the second act of the ceremony.

The Nominee must know and be prepared to sing each of the four (4) Solo Song Selections submitted via the Music Submission Form. While the Nominee and their Solo Coach will ultimately choose one of these four songs to work on during Jimmys Week, the Nominee must be familiar enough with the material upon arrival to sing each song for their coach in order to make the best determination for the Nominee.

Please provide the first choice up-tempo and ballad selections, in addition to a second choice/alternative as a back-up for each. Solo song selections should NOT be from the Nominee's nominated Qualifying Show. If you do not know or indicate the preferred key, sheet music will be provided in the original key.

The Jimmy Awards has compiled a Library of Approved Solo Song Selections that have already been vetted and edited by our music team for your reference and convenience. Should a Nominee wish to select a solo song that is NOT found in the below Library of Approved Solo Song Selections, you may still submit the song as a request for approval. Please see below for instructions.

If submitting a song NOT in the provided library, please indicate so by checking the appropriate box underneath the song title field on the Music Submission Form. Please note:

 are many shows on the Qualifying Shows List that are not Broadway productions.
- DO NOT submit solo song requests from shows that are not on the Qualifying Shows List, songs from Off-Broadway shows (even if the show is on the Qualifying Shows List and/or has been performed by a Finalist in the past), or songs from shows that opened on Broadway this season and/or do not have published sheet music.

Please do not assume that your solo song request is approved until you receive a definitive answer via music@jimmyawards.com. If a request is approved, an up to three-minute cut of the music will be uploaded to the Library and provided to the Nominee for use during the Jimmy Awards program if the Nominee is assigned to the Character Group following the Preliminary Adjudication. If the requested solo song will be used for Preliminary Auditions, the Nominee will still be responsible for bringing two (2) printed copies of their own sheet music with a clearly marked one-minute cut. If you are submitting a solo song request but do not yet have the rest of your materials ready for submission on Acceptd, please email a PDF copy of the completed Music Submission Form with the solo song request to music@jimmyawards.com so that we can expedite the request. If the solo song request is NOT approved for any reason, the Nominee will submit another song choice in its place.

Whether Nominees select songs from the existing library or submit solo song requests, no more than four (4) Nominees may select the same solo song as their first choice. If more than four Nominees have selected the same solo song as their first choice for either their up-tempo or ballad, there will be a lottery to determine which four Nominees will work on that specific song with coaches during Jimmy Awards Week. Final music determinations will be made by June 10, 2025.

Preliminary Audition Song Selections – A 32-bar cut of a song from the Nominated Role <u>and</u> a one-minute cut of a Solo Song, both of the Nominee's choice. To indicate which songs the Nominee will sing for the Preliminary Audition, please check the appropriate boxes on the Music Submission Form. Nominees will be required to bring two (2) printed copies of their sheet music for their Preliminary Audition Song Selections with cuts clearly marked for their Preliminary Coach and Rehearsal Pianist.

11. Inspiring Teacher Nomination Form & Video Response: Jimmy Awards Nominees have the option to nominate one (1) theatre teacher or teacher who leads the theatre program at the high school that produced the Qualifying Show for which they were nominated to be considered for one of two Inspiring Teacher Awards that will be presented at next year's Jimmy Awards ceremony. The goals of the Inspiring Teacher Award are: 1) to honor theatre educators for their commitment to excellence in high school musical theatre, 2) to raise the profile of teachers who present musicals at their schools, and 3) to honor theatre educators for their support of Jimmy Awards nominees.

Award Parameters:

- Recipients must be teachers of Jimmy Awards nominees in a full-time position at the high school that produced the Qualifying Show for which the student was nominated.
- Up to two (2) educators will be selected as the recipients of the award by a designated Taskforce.
- The Inspiring Teacher Award(s) will be bestowed at the following year's Jimmy Awards ceremony.

To Nominate a Teacher:

You may use the Inspiring Teacher Award Nomination Form. Any Nominee who wishes to nominate their teacher must make an approximately 60 second video describing or showing why their teacher deserves this award, provide additional information about their high school theatre program, and answer the following 6 questions in writing in complete sentences. *Please note that the content of the video should be distinct from the short answer responses. We encourage students to interview the nominated teacher, other students, parents of students, or other school community members who have been positively impacted by the nominated educator.*

- Why does your teacher deserve special recognition?
- Describe three (3) specific skills you have learned from your teacher.
- How does your teacher inspire you?
- How does your teacher make everyone feel included and valued in the classroom or in a production?
- What is the most valuable lesson you have learned from your teacher?
- What advice has your teacher given you about the professional world/life after high school?

NOMINEE CODE OF CONDUCT AND RULES

All students participating in the National High School Musical Theatre Awards (NHSMTA) program are expected to abide by the behavioral standards outlined by Juilliard below, as well as by the Summer Housing License and Juilliard/NHSMTA House Rules.

Curfew/Safety

For your safety, an 11:00 p.m. curfew will be enforced unless there is a scheduled group activity. Students must be in the residence hall by 9:00 p.m. or immediately following rehearsal when not at a group event and must be in their assigned rooms by 11:00 p.m.

Leaving Campus

Students are not permitted to leave campus without a chaperone. All participants and chaperones will travel to group activities together. All students, including those under the age of 18, must provide proper identification with a photo ID in order to enter the residence hall.

No Visitors Permitted

No outside guests are permitted in the residence hall or at any rehearsals, including immediate family. Access to Juilliard buildings and facilities is strictly controlled in order to ensure that students are granted the maximum amount of privacy and safety possible. Please be aware that unauthorized visitation to participants could result in their expulsion from the program with no refund.

Phone, TV, and Internet

There is no in-room telephone, television, or Internet connection. Wireless Internet is available throughout the residence hall lobby and lounges.

Personal Belongings

Students are responsible for all personal belongings. The National High School Musical Theatre Awards will not be held responsible for any lost, damaged, or stolen property.

Substance Abuse

Using any illegal substance (including, but not limited to, drugs and alcohol) is punishable by law and will not be tolerated. In addition, the NHSMTA program does not permit smoking and/or alcohol use of any kind, even if a student has reached the New York State legal age to use these substances. Any student who fails to comply with this requirement will be immediately expelled and disqualified from The National High School Musical Theatre Awards and no refund will be issued.

Respect

We will not tolerate discriminatory or harassing conduct toward any person affiliated with NHSMTA or outside of the program. 


